Identified as Lot-4, it contains approximately 6.15-acres of recently clear-cut timber that reduces your land clearing expenses and give you maximum flexibility as to where to place your home. -The property has approximately 350ft of frontage along Hughes Mill Road. -Additionally, the lot has acces along an easement road that runs along the eastern boundary. -Electrical service runs through the property and phone lines are along the frontage. -As a bonus, there's also a cell tower located 1/3-mile north of the property which provides excellent cell reception. -This lot comes with a new survey and a 3-bedroom septic permit is pending approval, making it ready for you to choose your builder and get started building your new home! -Here are a couple things to know when considering this property:

-There is confirmed 4G-LTE cell service with Verizon (a cell tower is just north of the property).

-A 3-bedroom Septic Permit is pending approval.

The local surrounding area has an abundance of outdoor attractions for the whole family. To the north, Caswell County offers some of the best outdoor activities in North Carolina as it boasts over 18,000-acres of state

game lands for all types of hunting, especially Whitetail Deer and Eastern Wild Turkey, and horseback riding (https://www.ncwildlife.org/Portals/0/Hunting/Game-Land-Maps/Piedmont/R-Wayne-Bailey.pdf). In Alamance County, there are a few incredible public access waterways for your recreational use year-round. -Local state parks and public lakes, like Graham/Mebane Lake is about 650-acres in size and offers fun for the entire family with its water skiing, bank, and boat fishing opportunities (<u>https://www.visitalamance.com/listing/grahammebane-lake/335/</u>), and Lake Cammack which offers excellent camping and fishing opportunities (https://www.burlingtonnc.gov/243/Lake-Cammack-Park-Marina).

The property is approximately 10-miles north of Mebane, NC, 11-miles north of Burlington, NC, 27-miles from Greensboro, NC, and 17-miles from the quaint town of Hillsborough, NC. All these cities & towns have shopping & dining opportunities as well as hardware and farm supply stores you may need.


