Located in the Boone Station Township area of east-central Alamance County, NC, you'll find this secluded +/-1.70-acre property that is a unique opportunity for anyone who's looking to build a home in a country setting, but still close to town!

A combination of Lots 2 & 3 on the recent survey, it contains approximately +/- 1.70-acres of fully wooded land ready for your new home.- Access to this tucked-away property is located on Howle Drive, via Greeson Lane (both are private roads), from Huffman Mill Road.

This lot comes with a new survey and has two approved septic permits for 3-bedrooms each, giving you many options and making it ready for you to choose your builder and get started building your new home!

Here are a couple things to know when considering this property:

-There is confirmed 4G-LTE cell service with Verizon.

-two 3-bedroom septic permits have been approved (see Property Documents Tab for details).

-The lot is subject to some Deed Restrictions, here are a few of the major ones for your consideration:

\*Residential use only.

\*Minimum 1,300 heated square feet for a single-story home; or minimum 1,800 heated square feet for a twostory home.

\*House pets only are allowed.

\*These restrictions were created prior to modern modular home techniques.- Mobile-homes may not be allowed; however, modular/site-built homes should be allowed.- Please review the Restrictive Covenants for more information (see Property Documents Tab for details).

\*No Homeowners Association.

\*No Road Maintenance Agreement.

\*No commercial use or activity.

-The building site is limited to one designated area on the lot (see Property Documents Tab for details).

-Schools District is Alamance County:

Highland Elementary - Grades: K-5 - Distance: 1.0 mi

Turrentine Middle - Grades: 6-8 - Distance: 4.7 mi

Walter M. Williams High - Grades: 9-12 - Distance: 5.0 mi

The local surrounding area has an abundance of outdoor attractions for the whole family. In Alamance County, there are a few incredible public access waterways for your recreational use year-round. The Lake Mackintosh Park & Marina is just a couple miles west of this property and offers fun for the entire family with its kayak & rowboat rentals, picnic sites, playground, pier & bank fishing, and boat ramp for your own boat ( <u>https://www.burlingtonnc.gov/245/Lake-Mackintosh-Park-Marina</u>).- Just a few miles east you'll find the Haw River and the Haw River Trail network.- This unique feature is still in progress and will eventually offer 80-miles walking/hiking trails along the Haw River (<u>https://thehaw.org/</u>).-

To the north, Caswell County offers some of the best outdoor activities in North Carolina as it boasts over 18,000-acres of state game lands for all types of hunting, especially Whitetail Deer and Eastern Wild Turkey, and horseback riding (<u>https://www.ncwildlife.org/Portals/0/Hunting/Game-Land-Maps/Piedmont/R-Wayne-Bailey.pdf</u>).

The property is approximately 13-miles west of Mebane, NC, 1-mile south of Burlington, NC, and 15-miles from Greensboro, NC.- All these cities & towns have shopping & dining opportunities as well as hardware and farm supply stores you may need.
