


## WITNESSETH:

That whereas Dorothy Ann Morrison Reddall died on March 10, 2014, leaving a Last Will and Testament which is duly probated and recorded in the office of the Clerk of the Superior Court of

Chatham County in File Number 14-E-186, therein naming said Carol Ann Reddall Burnett as her Executrix; and whereas said Grantor has duly qualified and is now acting as such Executrix; and whereas the Will of Dorothy Ann Morrison Reddall named Carol Ann Reddall Burnett and John William Reddall, III as the beneficiaries to the property described herein; and whereas all expenses of the estate have been paid outside of the estate;
